[Ohio Three \(3\) Day Notice to Leave Premises | NonPayment ...](#)

The three (3) day notice to quit for the nonpayment of rent, otherwise known as the Notice to Leave the Premises, is served upon a tenant who is behind on their latest installment to the landlord. The form must follow Statute 1923.04 which gives the tenant the seventy-two (72) hour period to either move -out or pay the rent.

Notice to Quit If the tenant broke their lease by committing an illegal act such as having drugs, gang activity, or breaking the law in any other type of way the lease shall be terminated immediately. The tenant shall have three (3) days to move-out.

The Ohio 3-day notice to quit, in accordance with 1923.04, when a tenant violates the terms of their lease or fail to make a rental payment on time.

A 3 day notice to vacate is made by any landlord when they need to vacate any of their tenants. Think of these like notice of disposal forms. You're disposing one of your tenants but you're giving them a 3 day notice to make sure that they're fully prepared by the time they have to vacate the premises. [Calculating the 3-day period the tenant has to pay or vacate on the 3-day notice is extremely important.](#)

Calculating the 3-day period incorrectly on the notice or filing the case in court prior to the expiration of the 3-day time period can very likely result in the eviction case being dismissed.

Start counting the three days on the first day after the notice to vacate was served. If the final third day is a Saturday, Sunday, or holiday, the three-day period will not conclude until the following Monday or nonholiday.

What: This is the required written notice with the required text for the state of Ohio, that gives the tenant the opportunity to pay the owed rent or vacate the premises within 3 business days before the commencement of court action.

### Ohio Eviction Process: Use a 3 Day Notice Form for Rent Owed

Depending on the reason for the eviction, the Ohio eviction notice may be 3-days or 30-days. 3-Day Notice For nonpayment of rent or in cases where the landlord reasonably believes the tenant or a person living on the property is involved in illegal drug activity, the landlord should send the tenant a 3 Day Notice to Quit form.

### California 3-Day Notice to Quit Forms | All Violations

...

The California 3-day notice to quit is to be used to identify a violation of a tenant's violation of their lease agreement either through their non-payment of the rent or of any other non-compliance such as having unauthorized guests on the premises, pet(s), sound (disturbance of peace), or other types.

### Eviction Process - Know Your Rights - Tenants Union of ...

A 3-day pay or vacate notice does not mean that you have to vacate the premises within three days. Eviction is a court process and your landlord cannot have you removed from the premises until a court order has been issued.

There are very few ways to stop an eviction for non-payment of rent, if you actually owe the money, besides paying your rent in full within the three day timeframe.
