For instance, in California, a Landlord may increase the rent of a month to month. If the increase is less than 10% a notice of this increase must be delivered to the tenant thirty days before it goes in effect however, if the increase is greater than 10% the notice must be delivered sixty days in advance.

RESIDENTIAL LEASE OR MONTH-TO-MONTH RENTAL AGREEMENT

A. Tenant agrees to pay \$ per month for the term of the Agreement. B. Rent is payable in advance on the 1st (or) day of each calendar month, and is delinquent on the next day. C. If Commencement Date falls on any day other than the day Rent is payable under paragraph 3B, and Tenant has paid one full month's Rent in advance of Commencement Date, Rent for the second calendar month shall be
