Once a tenant has moved out, most states give the landlord thirty days to return the security deposit, or a written explanation why it is being withheld.

Returning Security Deposits In order to try and return as much of the deposit as possible, the property manager should conduct a pre-move out inspection with the tenant. This will identify any items that will affect the deposit and give the tenant time to fix those items before the actual move out date.

Returning Deposits - Province of British Columbia

The rate of interest under section 38 (1) (c) of the Act [return of deposits] that is payable to a tenant on a security deposit or pet damage deposit is 4.5% below the prime lending rate of the principal banker to the Province on the first day of each calendar year, compounded annually.

The law in most states limits the amount of the deposit the landlord can collect, and gives the landlord a deadline for returning the deposit after a tenant moves out.

Requirements for Returning the Security Deposit When the tenant gives up possession of the property (which is usually when the tenant gives the keys back to the landlord), the landlord has 10 days to deliver a statement of account to the tenant.

FAQ - Can a landlord keep the security deposit if ...

No. A landlord cannot keep any of the security deposit to cover damage to the unit if inspection reports were not completed. A move-in inspection must be completed by the landlord and tenant one week before or after the tenant takes possession of the rental unit.
