While the landlord may choose to end your lease or raise your rent moving forward, state laws generally require a 30-day or 60-day notice before the tenant must vacate the premises. In most states, tenants who stay in their rental beyond the end of a lease without signing a new one are automatically shifted to a month-by-month lease.

Read the termination clause in your lease. For example, a lease agreement may state, "Tenant shall provide landlord with at least 10 days notice prior to vacating the premises.". In this situation, you should provide your landlord with notice at least 10 days before you move out.

The form you use to do this is called a Tenant's Notice to Terminate the Tenancy (Form N9). You can get this form from the Landlord and Tenant Board. Also known as a notice to vacate or a letter of prior notice, it is a document you or your landlord can issue to signal

the end of rental-related relationships. You should write such a letter to your landlord if you want to inform them of your intent to move out.

#### **Sample 30 Day Notice to Landlord - Free Move Out Example**

Once the landlord receives the tenant's 30 day notice, the tenant will still have to pay rent for the next 30 days unless the landlord is able to replace him with a new renter before that. Example: If you're a tenant and you send this notice on 18 May, you'll have to continue paying rent until 18 June.

A 30 day notice to the landlord is a notice sent to the landlord with the intention of ending the periodical agreement by the person who is renting the place. Notices. The requirement to provide written notice of some things before taking action is an example of this balance. For example, if the landlord wants to make repairs to the property, they must provide the tenant with 24 hours notice before entering.

#### **Tenant Notice to End Tenancy - Province of British Columbia**

Unless they have written permission from the landlord or the Residential Tenancy Branch, the tenant must pay the rent for the last month of the tenancy even if they move out earlier. The tenant must move out by 1 p.m. on the effective date of the notice the last day of the tenancy.

#### **Landlord Notice to End Tenancy - Province of British Columbia**

The landlord should talk to the tenant to confirm the moving date. If the tenant doesn't dispute the notice and does not leave by 1 p.m. on the effective date, then the landlord can apply for an Order of Possession a legal document from an arbitrator that orders the tenant to leave.

If a landlord gives the tenant notice to end the tenancy and the tenant wants to move out sooner, the tenant must still give the landlord 21 days written notice. If there are multiple tenants named on the tenancy agreement, and one of the tenants gives the landlord notice, this ends the tenancy for all the tenants.
